2.	Types of Material Information or Facts	:	Acquisition Transaction PT. Kurniamitra Duta Sentosa Tbk. ("Company").
3.	Description of Material Information or Facts	:	On September 26, 2024, PT. Dima Investindo ("DI") completed the acquisition of 440,000,000 (four hundred forty million) shares owned by PT. Miki Ojisan Indomitra ("MOI") in the Company, representing 55% (fifty-five percent) of the total issued and fully paid-up capital in the Company, at a price of IDR 420 per share or with a total purchase value of IDR 184,800,000,000 (one hundred eighty-four billion eight hundred million rupiah).

		The announcement of the Company's acquisition execution was published in the Investor Daily newspaper dated September 27, 2024, as attached.
4.	The impact of the event, information or material fact on the operational activities, law, financial condition, or going concern of the Issuer	: The acquisition of 55% of the Company's shares has resulted in a change of control over the Company as referred to in the Financial Services Authority Regulation No. 9/POJK.04/2018 dated July 25, 2018, on the Acquisition of Public Companies ("POJK No. 9/2018"). However, this event does not have a material impact on the Company's operational activities, legal matters, financial condition, or business continuity.
5.	Others	: In connection with the change of control over the Company, DI will conduct a mandatory tender offer for the Company's shares in accordance with POJK No. 9/2018.
