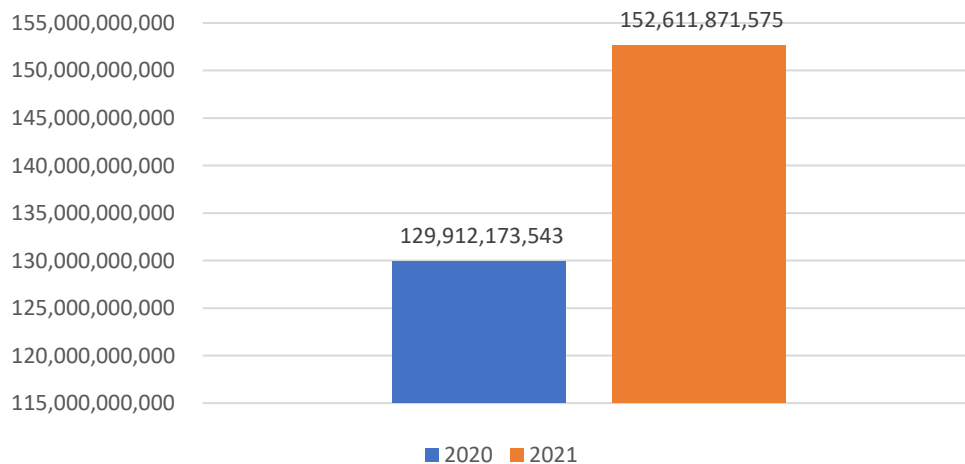

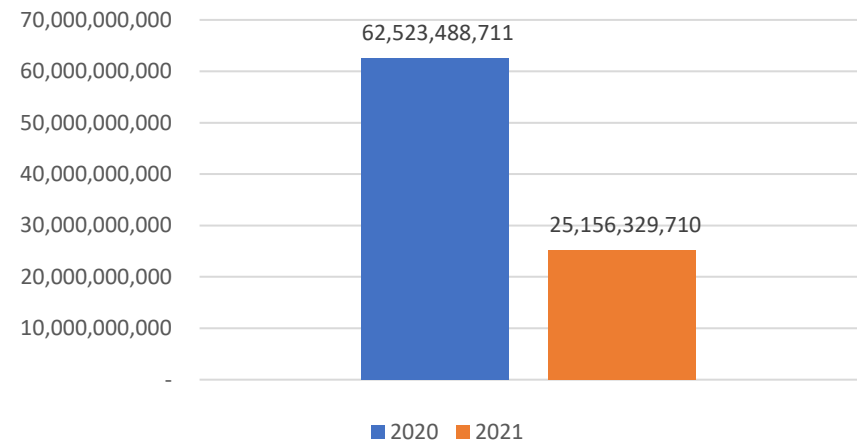

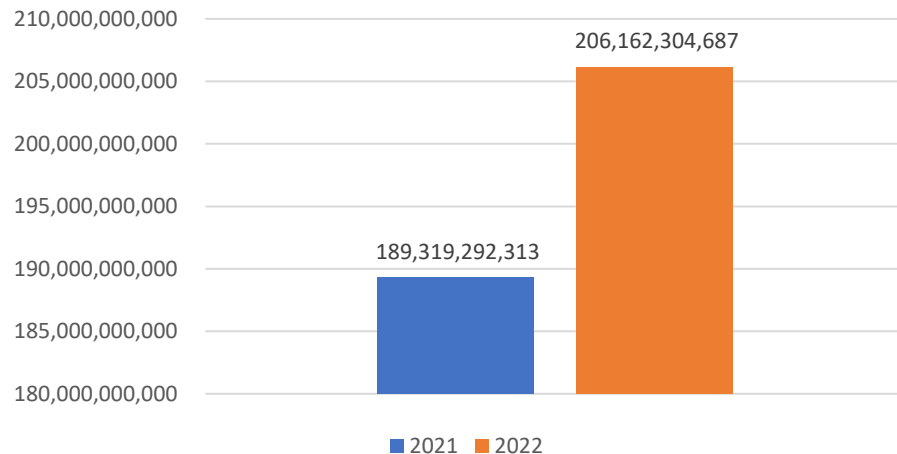

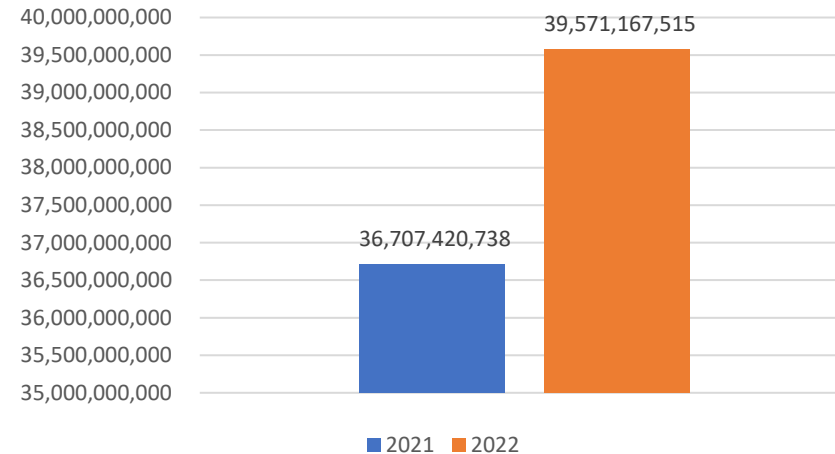

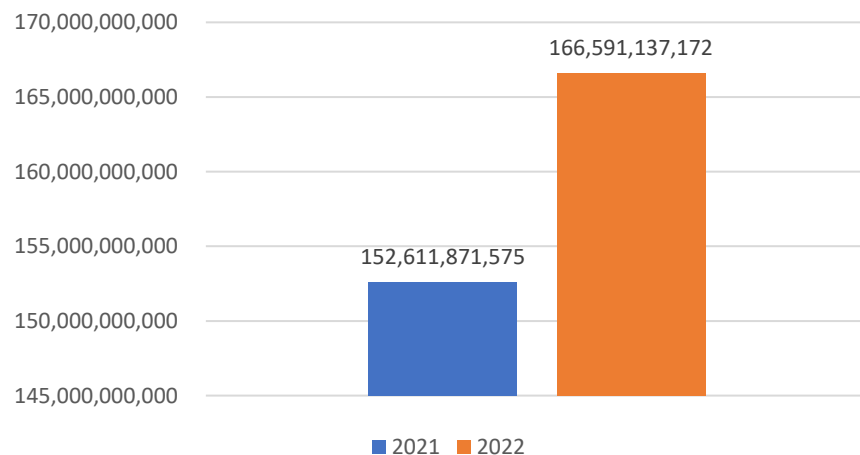
Aset KMDS mar 2022 vs des 2021



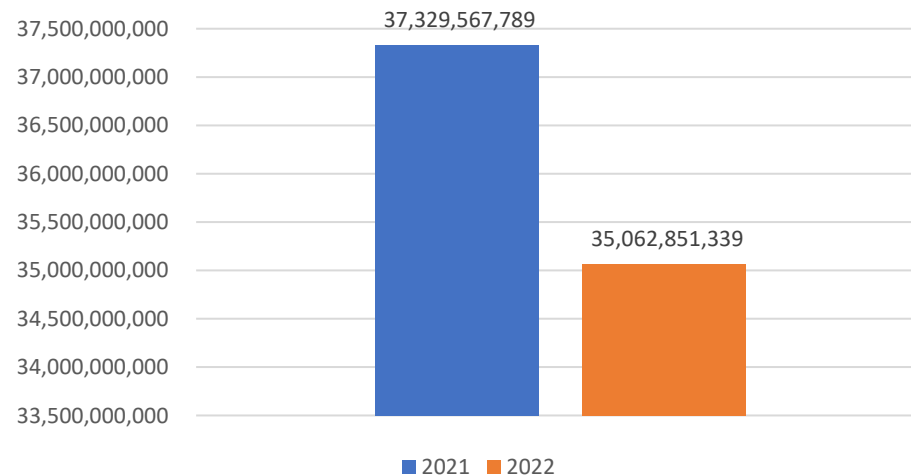

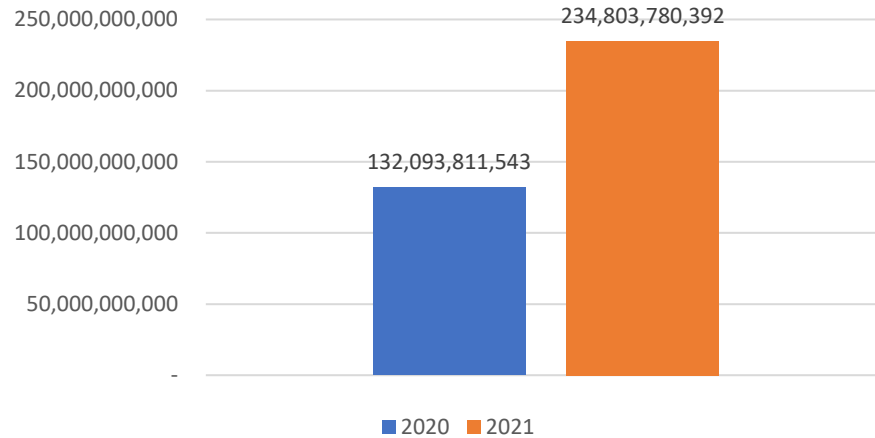

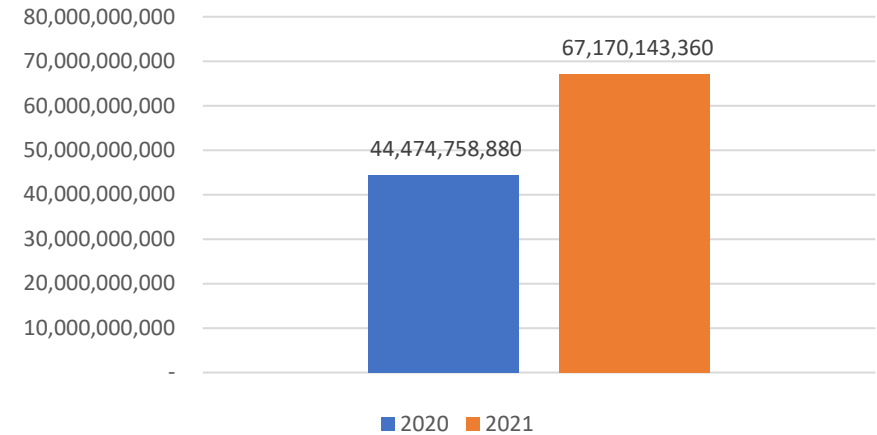

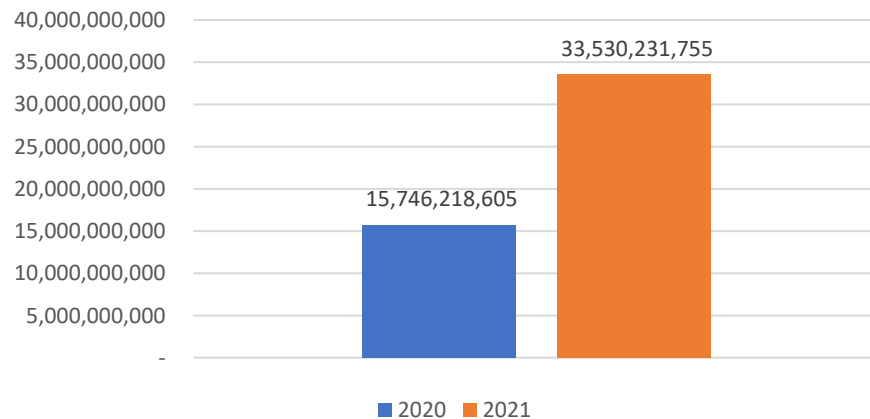

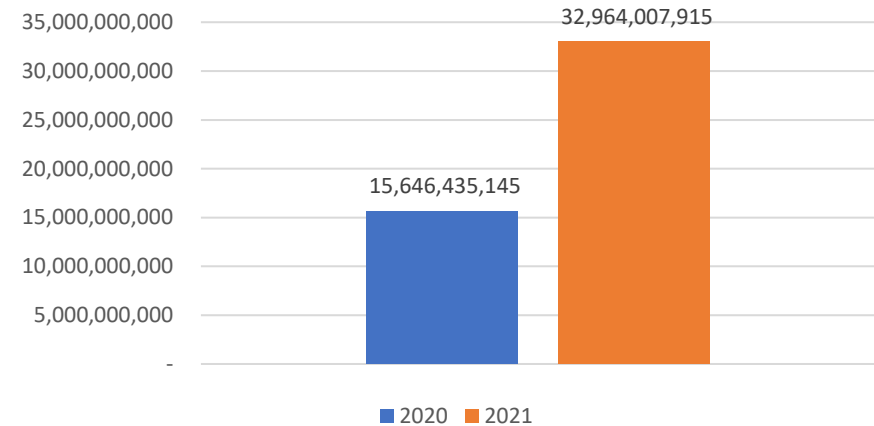

Laba Tahun Berjalan KMDS (sesudah pajak)

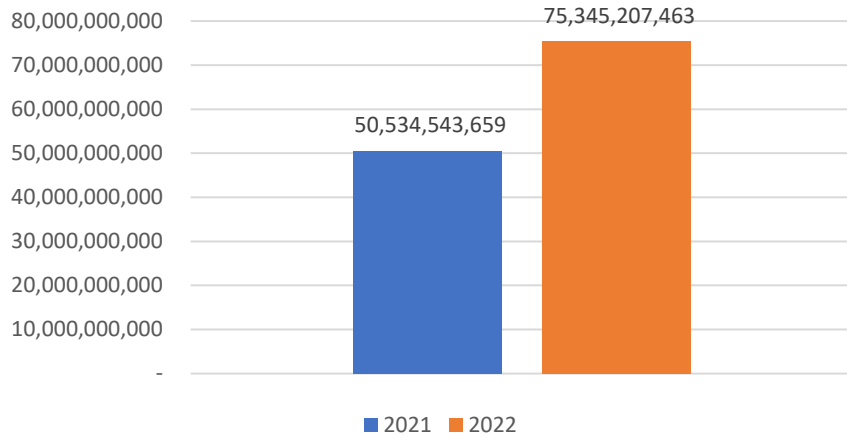

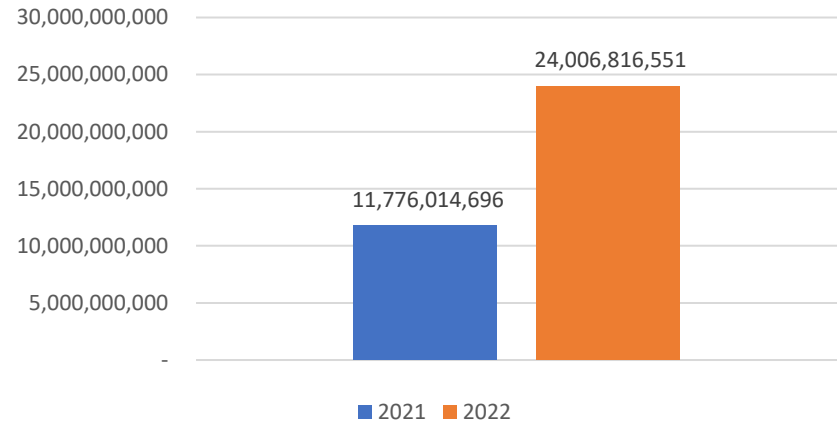

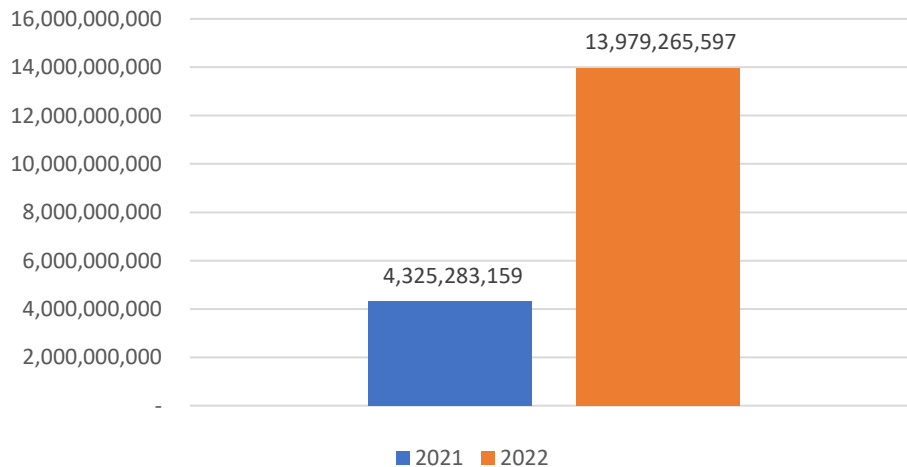
Pendapatan KMDS mar 2021 vs mar 2022



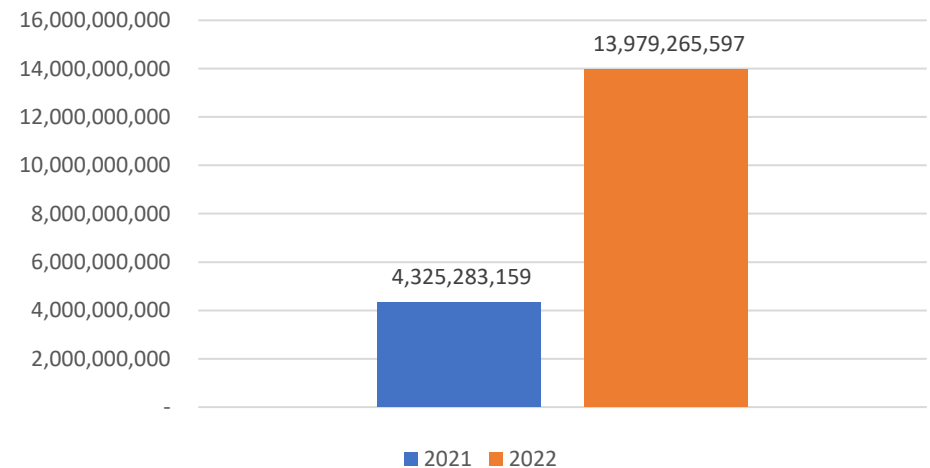
Lab Kotor KMDS mar 2021 vs mar 2022
